Sayın Üyemiz;

T.C. Ticaret Bakanlığının yazısına atıfla, Türkiye İhracatçıları Meclisinden alınan bir yazıda, Moskova Büyükelçiliği Gümrük Müşavirliğinden iletilen bir yazıda, Rusya Federasyonu Moskova Belediyesi'nin Moskova şehrinde kargo araçlarının hareketinin geçici kısıtlanması hakkındaki kararına göre, 22.02.2021 tarihi saat 22.00'dan 23.02.2022 tarihi saat 06.00'a kadar azami ağırlığı 12 tondan fazla olan kargo araçlarının Moskova çevre yolu (MKAD) dahil olmak üzere, şehir içine girişi ve hareketinin kısıtlandığı, ancak söz konusu kısıtlamaların izin belgesi sahibi ticari araçlara uygulanmayacağı bildirilmektedir. Söz konusu tek seferlik geçişlere ilişkin izin prosedürü hakkında detaylı bilgilere aşağıda yer alan web adresinden ulaşılması mümkündür.

Ref : About temporary restrictions of the movement of cargo vehicles in the city of Moscow

In accordance with Article 30 of Federal Law No. 257 - FZ of November 8, 2007 "On Highways and Road Activities in the Russian Federation and on Amendments to Certain Legislative Acts of the Russian Federation", paragraph 4.2 of Moscow Government Resolution No. 379-PP of August 22, 2011 "On Restricting the Movement of Trucks in the City of Moscow and Invalidating Certain Legal Acts of the Government of Moscow" (as amended by Moscow Government Resolution of February 16, 2021). No. 191-PP), the second paragraph of paragraph 5 of the annex to the Decree of the Government of Moscow of December 9, 2014 No. 723-PP "On the procedure for introducing temporary restrictions or stopping the movement of vehicles on the street and road network of the city of Moscow" in order to ensure road safety, I order:

1. Restrict the entry and movement within the territory of the city of Moscow, bounded by the Moscow Ring Road (hereinafter-the MKAD) and on the MKAD, including its internal and external sides, of cargo vehicles with a permitted maximum mass of more than 12 tons in the period from 22 hours 00 minutes on February 23, 2021 to 6 hours 00 minutes on February 23, 2022.
2. Restrictions (paragraph 1 of the order) for the entire period of the clock shall not apply to commercial vehicles in respect of which there are applicable pass, granting the right to enter and re-movement of trucks in areas restricting his movements in Moscow (paragraph 4.1.4 of the Moscow Government resolution dated 22 August 2011 № 379-PP "On the restriction of the movement of trucks in the city of Moscow and the annulment of certain legal acts of the government of Moscow").
3. Adviser to the head of the Department of transport and development of road transport infrastructure of Moscow Matasova E. V., gku TMS within one calendar day to provide information about events (item 1 of the order) in the media, including on the information resources of the Department of information technology of Moscow and the Department of transport and development of road transport infrastructure of Moscow.
4. Gku CODZ to develop and implement events to educate road users about the ways of the detour of the city of Moscow, MKAD limited, cargo vehicles with a maximum permissible mass exceeding 12 tonnes, portions of the Central ring road in the city of Moscow and the Moscow region.
5. To request the Department of the State Road Traffic Safety Inspectorate of the Main Directorate of the Ministry of Internal Affairs of the Russian Federation for the city of Moscow to ensure control over the implementation of measures (item 1 of the order) by road users engaged in cargo road transport.
6. I reserve control over the implementation of this order.
