T.C. Ticaret Bakanlığı İthalat Genel Müdürlüğü'nden alınan bir yazında, Fas tarafından 7213.91.90.00, 7214.20.90.00 ve 7214.99.91.00 gümrük tarife pozisyonları altında yer alan "**filmaşın ve inşaat demiri**" ithalatına karşı uygulanan korunma önleminin, 17 Ağustos 2021 tarihinde başlatılan bir gözden geçirme soruşturması ile 15 Ekim 2023 tarihine kadar uzatılmasına karar verildiği hatırlatılmaktadır.

Bu defa, bir örneği ekli 30 Kasım 2023 tarihli Dünya Ticaret Örgütü (DTÖ) bildiriminde, söz konusu korunma önleminin 10 yıllık uygulama süresinin sona ermesi sebebiyle sonlandırıldığı belirtilmektedir.

**NOTIFICATION UNDER ARTICLES 7.2 AND 12.1(C)  
OF THE AGREEMENT ON SAFEGUARDS  
(TERMINATION OF THE MEASURE)**

MOROCCO

*Wire Rods and Reinforcing Bars*

*Supplement*

The following communication, dated and received on 29 November 2023, is being circulated at the request of the delegation of Morocco.

Morocco hereby notifies the termination of the safeguard measure on imports of wire rods and reinforcing bars.

**1 THE DATE WHEN THE MEASURE CEASED TO APPLY**

The safeguard measure ceased to apply on 16 October 2023.

**2 DESCRIPTION OF THE PRODUCTS SUBJECT TO THE SAFEGUARD MEASURE**

The products subject to the safeguard measure are wire rods with a diameter of 5.5 to 14 millimetres and reinforcing bars with a diameter ranging from 5.5 to 40 millimetres. These products are imported under Moroccan tariff subheadings: 7213.91.90.00 (wire rods) and 7214.20.90.00 and 7214.99.91.00 (reinforcing bars).

**4 REASON FOR THE TERMINATION OF THE SAFEGUARD MEASURE**

The total period of application of the safeguard measure, including the period of application of any provisional measure, the period of initial application and any extension thereof, has reached 10 years.
