# Sayın Üyemiz,

Avrupa Birliği (AB) Nezdinde Daimi Temsilciliğimiz tarafından iletilen yazıya atfen, Ticaret Bakanlığından alınan yazıda; ülkemiz menşeli çift kabuklu yumuşakçaların denetimine ilişkin 2022/478 sayılı Uygulama Tüzüğü'nün uygulama süresinin 31 Aralık 2026 tarihine kadar üç yıl daha uzatma kararı alındığının belirtildiği ifade edilmektedir.

Bu kapsamda, AB Resmi Gazetesi'nin 25 Ocak 2024 tarihli nüshasında yayımlanmış olan Türkiye'den İnsan Tüketimine Yönelik Çift Kabuklu Yumuşakça İthalatına İlişkin Koruma Tedbirlerinin Uygulama Süresinin Uzatılmasına İlişkin 2022/478 sayılı Uygulama Tüzüğünü tadil eden 24 Ocak 2024 tarihli ve 2024/360 sayılı Komisyon Uygulama Tüzüğü'nün bir örneği ilişikte yer almaktadır.

#### **COMMISSION IMPLEMENTING REGULATION (EU) 2024/360**

### of 24 January 2024

amending Implementing Regulation (EU) 2022/478 as regards the extension of the period of application of protective measures on imports of bivalve molluscs from Türkiye intended for human consumption

(Text with EEA relevance)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2017/625 of the European Parliament and of the Council of 15 March 2017 on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products, amending Regulations (EC) No 999/2001, (EC) No 396/2005, (EC) No 1069/2009, (EC) No 1107/2009, (EU) No 1151/2012, (EU) No 652/2014, (EU) 2016/429 and (EU) 2016/2031 of the European Parliament and of the Council, Council Regulations (EC) No 1/2005 and (EC) No 1099/2009 and Council Directives 98/58/EC, 1999/74/EC, 2007/43/EC, 2008/119/EC and 2008/120/EC, and repealing Regulations (EC) No 854/2004 and (EC) No 882/2004 of the European Parliament and of the Council, Council Directives 89/608/EEC, 89/662/EEC, 90/425/EEC, 91/496/EEC, 96/93/EC, 96/93/EC and 97/78/EC and Council Decision 92/438/EEC (Official Controls Regulation) (¹), and in particular Article 128(1) thereof,

## Whereas:

- (1) Commission Implementing Regulation (EU) No 743/2013 (²) introduced protective measures on imports of bivalve molluscs from Turkey intended for human consumption. Commission Implementing Regulation (EU) No 2022/478 (³) provides for similar protective measures until 31 December 2023.
- (2) Those measures were introduced following Commission audits, which identified deficiencies in the implementation of official controls by the Turkish competent authorities on the production of bivalve molluscs intended for entry into the Union, and Member States' reports of non-compliant consignments of bivalve molluscs originating in Türkiye.
- (3) The latest Commission audits conducted onsite in 2022 and 2023 identified persistent deficiencies in the official control system overseeing bivalve molluscs intended for entry into the Union. These deficiencies revealed structural food safety processing shortcomings within Turkish establishments approved for exporting bivalve molluscs to the Union. If the existing protective measures were to be lifted, these unresolved issues would pose significant food safety risks for the products exported from these premises.
- (4) The period of application of Implementing Regulation (EU) No 2022/478 should therefore be extended for three more years to allow Türkiye to address the recommendations from the previous audits for entry of bivalve molluscs into the Union, and have these assessed by the Commission.
- (5) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on the Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

### Article 1

In the second paragraph of Article 5 of Implementing Regulation (EU) No 2022/478, the term '31 December 2023' is replaced by the term '31 December 2026'.

#### Article 2

This Regulation shall enter into force on the fourth day following that of its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
