Sayın Üyemiz,

Ticaret Bakanlığından iletilen yazıda, Pakistan Ulusal Tarife Komisyonu (Komisyon) tarafından ülkemiz menşeli **"Soda Külü"** (Pakistan Gümrük Tarife Cetvelinde 2836.2000 altında sınıflandırılan) ithalatına karşı bir anti-damping soruşturmasının başlatılmış olduğu ve söz konusu soruşturmanın başlatıldığına dair 18 Temmuz 2025 tarihli bildirimin ekte yer aldığı ifade edilmektedir. Bu itibarla, söz konusu bildirimde, soruşturmaya taraf olmak isteyenlerin taleplerini soruşturma açılış bildiriminin yayımlanmasından itibaren 10 takvim günü içinde, soruşturmaya ilişkin hazırlayacakları bilgi ve belgeleri ise açılış bildiriminin yayımlanmasından itibaren 45 takvim günü içinde soruşturma otoritesine sunmaları gerekmektedir. Öte yandan, soruşturma kapsamında yayımlanan "Soru Formu" ve "Şikâyetin Gizli Olmayan Kopyası", Komisyon'dan temin edilmesini müteakip Genel Sekreterliğimize iletilecektir.

Notice of Initiation of Anti-dumping Investigation against Alleged Dumped Imports of Disodium Carbonate (Soda Ash) into Pakistan Originating in and/or Exported from the Republic of Türkiye and the Republic of Kenya

National Tariff Commission (the "Commission") has received an application under Section 20 of the Anti-Dumping Duties Act, 2015, (the "Act") on June 27, 2025, from M/s. Lucky Core Industries Limited, Lahore and M/s. Olympia Chemical Limited, Lahore (the "Applicants"), who are producers of Disodium Carbonate or Soda Ash. The Applicants have alleged that Soda Ash is being exported to Pakistan at dumped prices from the Republic of Türkiye and the Republic of Kenya (the "Exporting Countries"). According to the Applicants, the alleged dumped imports of Soda Ash from the Exporting Countries have caused and are causing material injury and threat of material injury to the domestic industry producing Soda Ash.

Upon initial examination and scrutiny of the information and evidence provided in the application in accordance with Section 23 of the Act, the Commission is satisfied that the information and evidence provided in the application is sufficient to justify the initiation of this investigation.

Initiation of Investigation: The Commission hereby initiates an anti-dumping investigation pursuant to Section 23 of the Act. The investigation will determine whether Soda Ash originating in and/or exported from the Exporting Countries is dumped into Pakistan and whether such dumping has caused and /or is causing injury to the domestic industry within the meaning of provisions of the Act. The Commission, during the course of this investigation, will seek further information/data from the interested parties deemed necessary for the purposes of this investigation.

Product under Investigation: The product allegedly being dumped into Pakistan is Disodium Carbonate or Soda Ash (the "investigated product"). The investigated product is classified under Pakistan Customs Tariff ("PCT") Heading No. 2836.2000.

Period of Investigation (POI): For determination of dumping and injury, the POI is as follows:

For determination of dumping: From April 01, 2024 to March 31, 2025 For determination of injury: From April 01, 2022 to March 31, 2025

All interested parties are invited to submit their views/comments/ documents/evidence (if any) not later than 45 days of the date of publication of this notice in the press in Pakistan. Written submissions provided by interested parties on a confidential basis must be marked "Confidential" and in accordance with Section 31 of the Act, shall be accompanied by a non-confidential version/summary, which will be placed in the public file.
